
Website update



Treasurers Report for 2020 AGM

We know how everyone loves a treasurer's report, so we will make this matter of fact and short and sweet.

This has been an interesting year to say the least. A few numbers have changed, however not surmountable and the club is still in a good position.

For 2020, the club had a total of 137 memberships, (individual/family) including 4 life and 5 youth. This equates to a total of 246 people and approximately 186 Model A's.

During the year we had 8 resignations and 9 new memberships.

In these Covid times, the Club had 30 memberships, (individual/family) which were not renewed. However, this financial year, (2020/2021) has seen some of these non-renewed members renew.

Thus far for 2020/2021 membership subs paid has been great, and with further reminders prior to 15th November 2020, hoping there will be a lot more.

As indicated on the Statement of Receipts & Payments the club accounts open with \$28,650.76 and closed with \$28,788.51.

As per the Statement of Income & Expenditure excess of income over expenditure is \$877.24.

- give a true and fair view of the position of the Club as at 31 August 2020 and the financial results of its activities for the year ended on that date.

My audit was completed on 14 October 2020 and my qualified opinion is expressed as at that date.



The following article was taken from the Restorer magazine. We would like to acknowledge them for publishing another fine article for our members to enjoy and learn from.



Model A Ford Zenith carburetors can be very troublesome. This is why I make it a practice to thoroughly road test any Zenith I restore before it ever leaves the shop. I install them on my Victoria which is a very good running car. If the car does not run well with the test Zenith, I immediately know it is the carburetor and not the car. I usually put at least 20-30 miles on it over a period of a number of days of daily driving before it is pronounced a good functional Zenith.

A recent restoration gave me some difficulty. When I bolted it onto the Victoria, it started right up, idled well, did not stall at a stop, and when I could get it up to high speed, it ran fine. The problem was getting it up to high speed.

It would hesitate when accelerated, cough and sputter and carry on. Once it was warmed up, it ran much better, but it was still not right. Opening and closing the Gas Adjusting Valve (GAV) control to different positions did not help any.

I took the Zenith back off and blew all the jets out, separated the castings, and checked it over and could not find anything obviously wrong. I reinstalled it back on the car, and it functioned the same.

The Zenith had been gone through extensively. The throttle bosses had been drilled out, new bushings installed and reamed to accept a new throttle shaft. Both castings had been bead blasted and painted. All the passageways had been run through with a paperclip. The four jets had been flow tested and re-sized. One thing I did note was that the Zenith was an early version that has the brass GAV seat that screws into the base of the GAV tunnel. I had made a note of it and replaced it with a new reproduction one during the assembly process.

When installed back on the car, it performed the same. My thinking was that the problem has to be in the secondary circuit. This involves the comp jet, the cap jet, and the GAV circuit. Something must be plugging somewhere, either in a passageway

or a jet. The resolve was to once again remove it and completely disassemble it and check everything.

When I removed the GAV assembly from the GAV tunnel, the brass GAV seat came out with it stuck onto the end of the needle valve. See above photo.

Over the years, I have heard the story that Ford instructed Zenith to discontinue the removable brass GAV seat in favor of the seat being cast into the housing. The reason given was that some Model A owners were turning the GAV control down tight and when they backed it off, instead of the valve opening, the brass GAV seat unscrewed because the two brass parts had seized together.

And that is exactly what happened. Only in my case, I had not screwed it down tight, all I did was bottom the needle in the valve slightly, and then backed it out. Apparently, the reproduction GAV seat I installed had a burr on it.

I have worked on many Zeniths of the early version with the brass GAV seat, but this is the first I have seen of the needle valve seizing and the brass GAV seat backing out.

The brass GAV seat had seized very tightly onto the end of the brass needle valve. It would screw out and screw in each time the GAV control was adjusted without actually opening the valve and porting fuel into the secondary circuit.

I replaced the brass GAV seat with an original one and the entire GAV assembly as well. Once back on the Victoria and out on the road, the Zenith performed perfectly, just as Henry ordered.

Nine NIMAFC members were booked to travel AKL-CHC for a Swap Meet long weekend, organised by John Castle. Like most Kiwis, we were hanging out for any sort of post-lockdown break. We decided to go anyway. Garry Learmonth and I were McLeans Island Swap Meet newbies, joining *The Old Originals* of John Castle, Steve Driver, Terry Costello, Bruce Stratton, Murray Ashby, Ross Bolton and Paul Hunter.



8 October

Covid-19 Alert Level 1. Optional in-flight masks. Blue skies in Christchurch for our 4-day visit, mostly jacket-on weather, but occasionally a welcome jacket-off period. Rental minibus from Christchurch Airport to Dave Yates' Harewood property, with a look over his extensive workshops. Points of special interest were a 1925 Case tractor well into restoration; an all-comforts compact, mobile fishing "lodge" cleverly built on storage tanks and able to be backed lakeside for fishing off the deck, and a 1-ton Voest radial drill. Dave has had a lifetime as a contractor and is clearly enjoying his retirement.

9 October

Breakfast fuel-up at the Riccarton Mall, then on to the Vintage Car Club's parts shed at McLeans Island. I'd always imagined Canterbury VCC members driving across a causeway to a coastal McLeans Island, studded with clubrooms, volunteer-built sheds and suchlike. But no, it's a former island in the braided Waimakariri River (flowing from Southern Alps to the Pacific Ocean). And now very much part of the flat, flowing, farm landscape. This impressive home to the Canterbury VCC fraternity is built on hectare upon hectare of former riverbed grounds, lightened with extensive tree planting. Expansive buildings here, with parts sheds extending aisle after aisle, rack after rack, to gladden the heart of any repairer/restorer. *Including* a Model A Ford section! As a first-time visitor, volunteer Parts Manager, Wayne (Stoxy) Stocks took me on a tour of discovery – including one immense shed with rows of complete engines. Ever hospitable, the VCC visit ended with hot drinks and home-made shortbread.



Further along McLeans Island Road is the 14-hectare Keating Park, home to the New Zealand Vintage Machinery Club. Dave Yates, again generous with his time, met us at the site, about 20km from the city centre. Keating Park is home to an impressive range of vintage machinery and memorabilia. Agricultural, industrial, woodworking; all fully restored or awaiting restoration. Notable was a fully restored Jessop & Appleby 10ton crane (see photo) ordered from England (1901) by the Timaru Harbour Board. Assembled in Timaru, the crane was used to build the harbour breakwater. The



photo shows John Castle with 2 contrasting tractors – a modified Farmall and a miniscule Austin 7 conversion.

Next, a welcoming Ian Smith showing us his car collection, including 4 Model A's – a 1930 Standard Roadster, a very smart 1931 Deluxe Roadster, rare 1931 Deluxe Phaeton and a well-patched 1930 "Hillbilly" Pickup conversion. It wasn't difficult to imagine a farm owner loading fence posts and possibly a few sheep onto this faithful workhorse. Beside the Model A's, spiffing Minis and others, a red E-Type 2 + 2 Jaguar shouted "look at me"! I've loved these iconic cars since my 1960s high-school days.

Then via Lincoln, Springston and Doyleston to Leeston. Christchurch is wellendowed with productive, flat farmland, seamlessly wrapped in smartlytrimmed shelter hedges and the odd gorse hedge.

In Leeston, Danny & Sharon O'Malley showed us their eclectic collection, including a late 1920s Dodge, rare 1958 6/90 Wolseley Police Car and 20-foot long 1959 Cadillac Eldorado convertible with matching yellow upholstery. No other car achieved the height of the gigantic tapered fins on the Eldorado.

10 October

To Prebbleton where an alternative Swap Meet had been arranged in the paddock of a private property. Most of us found a treasure or three. Breakfast options – Mr Whippy, bacon buttie (popular), coffee. Bruce Miles in *Angus*, his famous always-roof-down 1930 Phaeton, still faithfully upholstered with well-worn sacks, greeted us with his usual warmth.

We'd heard of 2 Model A's for sale at Greenpark Huts, Lake Ellesmere. But on arrival, the owner had temporarily disappeared – we resorted to peering through dusty garage windows at the outlines of a 1928 Roadster and 1929 Sedan, both unrestored. Our consolation was being invited into a neighbour's home.

On to lunch at Governors Bay, then via the Lyttleton Tunnel to Rangiora and the 2000 square metre collection at Richard Spark's Northbrook Colonial Museum. This is eccentricity at its best. Starting 38 years ago, coincidently at age 38, Richard has amassed a mostly Kiwiana collection well north of 200,000 artefacts. Amid all this social history, I asked Richard what single



item he treasured the most. "Come with me". We wove in and out of aisles, eventually stopping in front of a glass case. "See those leather trousers. They were worn by Samuel Wilkes, a Royal Marine on Nelson's flagship *HMS Victory*, at the 1805 Battle of Trafalgar". Remember, this was the sea battle that allowed Britain to become the largest sea power for 100 years. And here was an item worn in the heat of that very battle!

Richard's late brother, Bob, collected Allis-Chalmers tractors – at least 40 in pristine condition line up at one end of the museum building. Every example of pre-war Allis-Chalmers is represented.

Model A enthusiasts, Alan & Barbara Hill, also live in Rangiora and were next on our visiting list. Alan (see photo) is meticulously restoring a 1923 Chalmers. Alan & Barbara are also proud owners of 3 Model A's – a 1928 Sport Coupe, a 1930 Roadster Pickup and a 1931 Phaeton.

11 October

The Sunday Riccarton Market is one of the largest outdoor markets in the country and a major icon in Christchurch. Run by the Riccarton Rotary Club, it has a great mix of craft, second-hand tools, books, toys, records, clothing, food, knitting and

more. We all rummaged through treasures and junk. With encouragement from fellow Model A'ers, I bought an oilskin hat with fold-down possum fur flaps. Perfect for a mid-winter drive in the Phaeton.



A call this morning to Harry Orpwood's property. Among a spreading collection, Harry owns a 1932 Roadster with a surprisingly quiet V8 engine. Also a 1930 Pickup, looking off-road ready for the next Irishman Creek wintertime rally (see photo).

We returned to Auckland in the afternoon, everyone agreeing we'd had a perfect South Island post-lockdown sojourn (Jenny tells me the girls had a perfect sojourn at home too!). A special thanks to all our hospitable and welcoming South Island hosts.

Thank you to all the members who made the good call to ignore a few showers and venture with us to the West Coast.






The following article on Safety was also taken from the Restorer magazine. We would like to acknowledge them for providing this very important message to all Road users.

As a serving police officer, I have attended numerous road crashes in my time. I have seen motorists taking the utmost care after being involved in accidents. IE: standing off the road, placing out cones, wearing reflectorised jackets etc. Unfortunately, there are other motorists out there that still do not see all these clearly obvious safety / warning signs, or in fact the accident itself. I have attended an accident where a motorist has been driving along the road. The driver looked to his left at a broken down 1938 Ford which grabbed his attention, then forgot to look back at where he was supposed to be going. He then crashed into the tow truck that was ahead of this 1938 Ford, causing injuries to the tow truck driver. A classic case of rubber necking a classic car.

Please, please, never assume that everyone has seen you, or that every motorist is an observant or safe driver. People get distracted, IE: using their cell phone whilst driving. It's in that moment that they may not see the warning signs, or your precious vehicle, or even YOU on that road. We have a saying in the Police which we think of as we attend incidents. **I AM GOING HOME TONIGHT!!** Please do the same.



The safety officer also encourages club members that are not working on the car to remove their cars to a safer area and to eliminate onlookers from congregating near the roadway.

Second, all cars are equipped with a hand-held radio to actively communicate issues that are of importance to others in the tour, especially potential safety issues.

Third, understanding that if a serious accident occurs with a classic car, where paramedics are needed, those paramedics (or hospital personnel) can be severely limited in providing medical assistance without some knowledge of the medical history of the patient. To that end, the club created a "medical history" form that lists current medical conditions and prescription drugs for each club member. The medical history form is dated and is



imperative to the safety of those repairing the car.



updated on a regular basis. The form is sealed in an envelope with the name of the member/s on the front, and the sealed envelope is carried in a waterproof container by the safety director on each trip. The sealed envelope would then be provided to the medical personnel in the event of a serious accident.

Fourth, the club recognized that during the course of a trip or tour minor injuries occur that do not require formal medical intervention, but need to be addressed. The club contributed club funds to the development of a medical bag containing bandages, elastic bands, first aid cream, insect bite medicines, tape, aspirin, stethoscope, scissors, cotton balls, antiseptic creams and fluids, saline eye flushing solution, etc. The medical bag is also carried by the safety director.

Fifth, knowing that time is of the essence in heart related incidents and recognizing that the membership of our club is comprised of older members, the club invested a significant amount of money for a portable Automated External Defibrillator (AED) and held classes with the membership on how the AED is to be deployed. As with the other safety equipment, the safety director is in charge of the AED.

Sixth, the safety director monitors traffic behind him, notifying the other drivers of passing cars or to let the tour leader know to move over to let a long string of cars pass. Realizing that some drivers on the highway become frustrated by the line of classic cars ahead of them, and may cause them to make unsafe driving decisions, we try to minimize our risk by being proactive in yielding the road to them. In that way, our tours end up having "Miles of Smiles" and few accidents. The noted risk management guru, Gordon Graham, states in all his lectures the following axiom, "If it's predictable, it's preventable."

The A's R Us Model A Car Club has established these measures to reduce the risk of injury to our members during club activities. We think they are worth consideration by other classic car clubs as they consider protecting their most valuable asset...the member!


